A number of post-1922 instruments were made under the collectively cited Poor Law Relief (Ireland) Acts 1838 to 1914 (and other provisions), and may have ceased to have effect because of repeal of their enabling provisions. In any event, they appear to be obsolete and should be revoked: The Country Boards of Health (Assistance) Order 1924 (unnumbered, made 14.03.1924), S.R. & O.
